When last we wrote you, we had made the difficult decision to postpone May travel for GO due to COVID-19. We continue to watch the situation and are moving forward with other program postponements. We remain hopeful that things will change and travel will be possible in July, but are also starting to make contingency plans in case they don't.

Therefore, we wanted to share the possibilities:

- If FOCUS Australia program is able to run in July 2020, as planned final decision will be made in May 2020
- If FOCUS Australia is not able to run in July 2020 as planned:
  - You can participate in a different Winter 2020/2021 program note that applications are open on go.susqu.edu until April 15. Programs that don't fill will be reopened after the 15<sup>th</sup>.
  - FOCUS Australia program runs May 2021 you would still be able to participate in this program, however, I do want to note that, for current May 2021 anticipated graduates: after the program is completed, your graduation requirements would be completed but that your final conferment of your degree would be August 2021 – decision for this would be May 2020

We are as disappointed about this situation as we are sure that many of you are - and we have made this difficult decision on the basis of what we feel is in the best interest of your personal health and wellbeing.

While the due date for the program fee was on 3/31/2020, we will work with Student Financial Services to ensure there are no interest, late fees, or negative effects for postponing our payment at this time.
